
Directions to Show site

From **I-405** headed **Northbound** take 522 East /EXIT 23 (to Woodinville/Monroe).
Take the NE 195th Street exit
Go **LEFT** at the light (195th), back under the highway
Turn **RIGHT** at 130th Avenue NE
Turn **LEFT** at 244th Street East
Sharp **RIGHT** onto 47th Avenue SE
About 1/2 mile further the main road makes a complete left angle turn.
At that point go forward through the front gate instead of following the road to the left. There is a large brick wall and gate house, with a large sign above the wall. Follow signs to show.

From **I-405** headed **Southbound** take EXIT 26 - Bothell/Mill Creek
Exit **RIGHT** onto Bothell-Everett Highway/527
Get into the left hand turn lane
Turn **LEFT** at the light onto 228th
Go about 2 - 2-1/2 miles to the top of the highest hill
Turn **RIGHT** onto 45th Avenue SE
45th Avenue ends at a 4 way stop- at 240th Street SE
Turn **LEFT** onto 240th Street SE
2 Blocks later the road makes a complete right-angle turn - turn **LEFT** into the gates. There is a large brick wall and gate house, with a large sign above the wall. Follow signs to show.

### Entry Information and Policies

- Pre-entry closing date is Wednesday, **January 18<sup>th</sup>, 2012 6:00pm.**
- Licensed classes & non-licensed classes are limited to 55 dogs per day. Licensed class entries shall have preference.
- Day of trial entries will be accepted before 7:45am if the trial is not filled. Check with Trial Secretary after the closing date.

- **Entry forms:** MVDTC reserves the right to return incomplete or incorrectly filled out entries, or entries with insufficient funds.
- **Entry fees:** If you are not sure about the entry fee amount, please ask ahead of time, or send the greater amount, and the club will refund any overage. We thank you for reducing the number of long-distance phone calls the secretary must make by ensuring your entry is accurate and complete, and emailing inquiries whenever possible.
- **Registration #s:** U.K.C. rules prohibit the acceptance of entries with "pending" or missing registration numbers.
- **Jump Height:** please remember to include dog's height on entry form. Note that in UKC, Open Class dogs jump *twice their height at the withers* for the broad jump (not twice the height of the high jump).
- **Refunds:** exhibitors who withdraw from the trial, in writing, prior to the closing date will be refunded their entry fee, minus a \$5 processing fee, per entry. Refunds are not given for entry cancellations after the closing date, except for bitches in season, as allowed below.
- **Bitches in season** may not compete. Entry fees for bitches that come into season after the closing date will be refunded, minus a \$5 processing fee. These cancellations must be made prior to the start of the trial, and a veterinarian certificate must be provided to verify that the dog is in heat.
- **Move-ups:** Exhibitors may move up to the next class for the next trial after finishing a title. Move-ups must be presented to the Trial Secretary no later than ½ hour after completion of the trial in which the title was earned.
- **Liability:** Neither MVDTC nor the United Kennel Club, Inc. is responsible for theft, loss, accident, or injury to any dog, person, or property at any of its events. Absolutely no alcoholic beverages or drugs are allowed. Aggressive behavior by dogs shall not be tolerated at U.K.C. events. Due to space limitations, MVDTC reserves the right to ask that non-entered dogs be removed from the show site.
